C. Contract Information

ISDs occasionally enter into contracts with vendors to perform specific services that would not be cost effective or reasonable for the ISD to provide on its own. Oakland Schools Board Procedure 3610 requires the ISD to obtain competitive price quotes for supplies, materials, and equipment purchases that exceed \$5,000 but are less than the current state board approved amount, as required by law. In FY 2019-20 state law further required that Oakland Schools conduct competitive bids when the cost is estimated to exceed \$24,924 for supplies, materials and equipment purchases and for construction, renovation, repair or remodeling. Michigan law does not require school districts or intermediate school districts to competitively bid service contracts or operating leases. Below are the contracts required to be reported under this section.
